Supporting the Tai Po Fire Victims

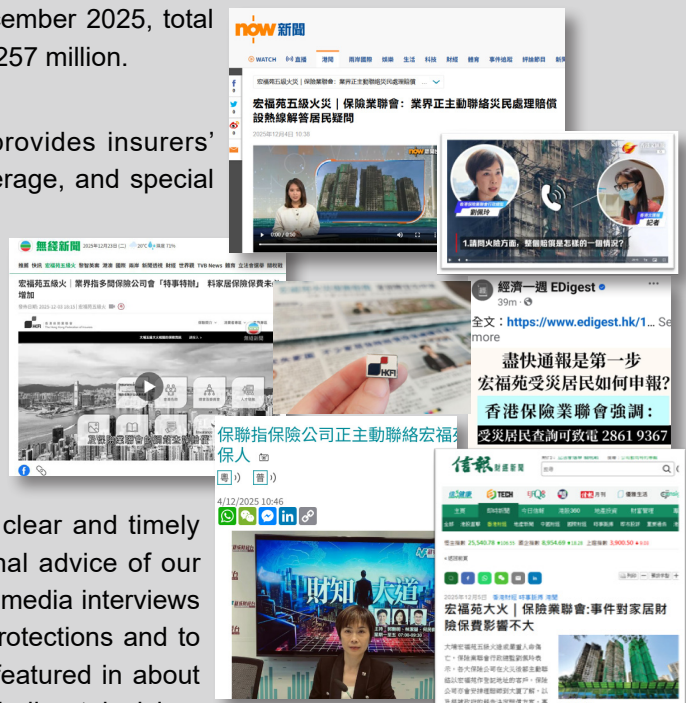
According to the Insurance Authority (IA), as at 19 December 2025, total insurance payouts by insurers have already exceeded \$257 million.

HKFI Hotline

In addition to launching a dedicated webpage that provides insurers' hotlines, comprehensive information on insurance coverage, and special alleviation measures for the Tai Po Fire victims, the Secretariat has also set up a hotline to assist family members of the deceased in locating insurance policies. Thanks to the swift support of our Member Companies, we were able to help bereaved families identify their insurers and connect them with the necessary assistance.

Accurate and timely communications

During such challenging times, it is crucial to provide clear and timely information about insurance. Guided by the professional advice of our Members, the HKFI Chief Executive conducted multiple media interviews to deliver accurate explanations of various insurance protections and to dispel misinformation. Altogether, our messages were featured in about 90 news coverage across nearly 40 media outlets, including television, radio, newspapers, and online platforms.



Collective Donation Drive

HKFI has initiated a collective donation drive with a seed fund of HK\$500,000 allocated by the Governing Committee. Many insurers, including the non-HKFI members, responded positively to our call for action. In total, we have collected HK\$8,667,399 from 22 insurers and their staff. Together, the HKFI-led Donation Drive contributed HK\$9,177,399 to the Government's "Support Fund for Wang Fuk Court in Tai Po," reaffirming our commitment to stand by the community during its recovery.

Southbound Travel for Guangdong Vehicles

We welcome the first batch of Southbound Travel for Guangdong Vehicles (STGV) entering Hong Kong's urban areas on 23 December. We are pleased to note that these STGV drivers have obtained proper insurance coverage from the six Hong Kong motor insurers offering such coverage.

The HKFI has launched a series of posts on RedNote to help mainland drivers better understand Southbound Travel insurance, including product features, Hong Kong law, accident handling procedures, claims tips, and more.



Best Practice on Roadshow Activities

In 2021, HKFI issued a notice to Member Companies reminding them to implement adequate control measures and policies to prevent the misuse of company marketing materials and to uphold the industry's professional image and standards of etiquette.

To go one step further, the Professional Standards Working Group (PSWG) under Life Insurance Council of HKFI took the initiative to develop a Best Practice on Insurance-Related Roadshow Activities in Hong Kong (Best Practice) with the aim of providing clear and practical guidance for conducting roadshow and promotional activities ethically and professionally. A consultation among our Member Companies on the draft Best Practice was conducted in November 2025. With support from the IA, the HKFI issued the Best Practice on 19 December 2025, effective from 1 January 2026 (Circular no.: Mv 082/25).

We look forward to the support from Members for this newly launched initiative!

External engagements

General Insurance Association of Malaysia

We held a virtual meeting with the General Insurance Association of Malaysia (PIAM) to discuss developments in Electric Vehicle (EV) insurance. With EV adoption on the rise, both organizations shared insights on the current market landscape and emerging needs. The discussion also explored technical considerations and assessed the industry's readiness to meet the evolving demands of this growing sector.



The Worldwide Chinese Life-Insurance Congress

The 16th Worldwide Chinese Life-Insurance Congress, an event anticipated to draw over 10,000 attendees, is scheduled to be held in Hong Kong in August 2026. On 10 December 2025, the delegation, led by Mr Liang Tien Lung, the IMM Founder, visited HKFI to explore potential support and collaboration.

Public-Private Synergy: Shaping Hong Kong's Insurance Future

In early December, HKFI took part in Asia's largest insurance conference in Hong Kong, joined by over 100 representatives from our Member Companies. At the leadership track session titled "Public-Private Synergy & Hong Kong's Insurance Ascent", HKFI Chief Executive Ms Selina Lau engaged in a fireside chat with Ms Alpha Lau, Director-General of Investment Promotion of InvestHK, where they discussed strategies to strengthen Hong Kong's position as a global insurance hub.
